




### 1. Course content of the syllabus was updated and relevant


### **Observation**:

### **Observation:**






### 5. Program was capable of catering to my requirement


### **Observation:**




### 7. Syllabus prescribed was well organized and structured



1. Ability of employee to apply the knowledge of the course in his work


### **Observation:**

### 2. Ability to work as a team



### **Observation:**



### **Observation:**



### 5. Curriculum is relevant to the local and national educational needs


### **Observation:**

### 6. Is the syllabus research oriented?






### 8. Overall performance of the employee is good


### **Observation:**


### 10. The course has good balance between theory and practical


1. Board of studies is taking care to ensure the currency and relevance of the programme offering.



### **Observation:**




### 3. Enough freedom to contribute my ideas on curriculum design and development


4. The system followed by the Institute for the Design and development of curriculum is effective.



### **Observation:**



### 5. The curriculum has been updated from time to time.








### 7. Course outcomes and program outcomes are well defined and clear

### **Observation:**






### 9. Course has good balance between theory and practical




### **Observation:**

### 2. Course curriculum intellectually stimulate you








### 4. Open courses offered as per NEP were diverse and resourceful


### **Observation:**




### 6. Program was capable of catering to my requirement


7. Syllabus create any interest to pursue post-graduation/ Research in the particular topic



### **Observation:**




### 9. The course contents have good balance between theory and practice




1. Academic discipline (i.e. timely conduct of lectures, practical)


### **Observation:**

### **2.** Admission procedure








### 4. Examination system adopted by the college


### **Observation:**




### 6. Infrastructure and Computer lab facility


### 7. Library Facility




### **Observation:**




### 9. Sports and cultural activities

# **IQAC Recommendation**

- Industry Interaction must be enhanced in order to improve the placement.
