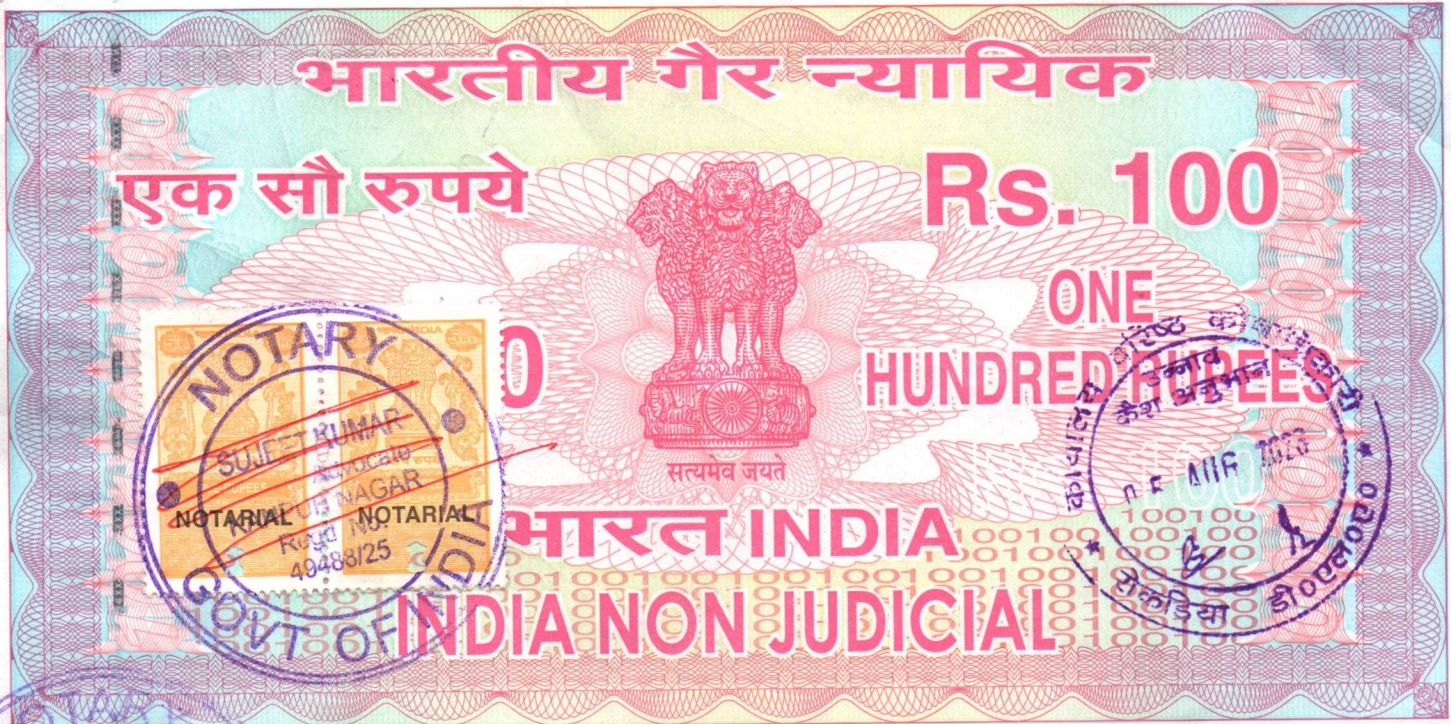

AFFIDAVIT

FOR CHANGE OF NAME OF SCHOOL FROM "MOUNT LITERA ZEE SCHOOL, UNNAO" TO "GGES INTERNATIONAL SCHOOL"

I, **Anil Kumar Verma**, S/o **Tej Ram Verma**, aged about 64 years, resident of 102 Ratan Castles, 7/29 B, Tilak Nagar, Kanpur, presently working as **Chairman of Great Ganges Education Society**, having its registered office at **Flat No. 102, Anand Keshav Apartment, 8/220 Arya Nagar Kanpur**, do hereby solemnly affirm and declare as under:

1. That **Great Ganges Education Society**, registered under **Society act 1860** vide Registration No. 764/ 2007-08, is the Society running and managing the school presently known as "**Mount Litera Zee School, Unnao**", situated at **Kanpur-Lucknow Highway, Gram Gadan Khera, District Unnao, Uttar Pradesh**.
2. That the Society has resolved to change the name of the school from "**Mount Litera Zee School, Unnao**" to "**GGES International School**" and has duly passed a resolution to this effect in its meeting held on **04/08/2026**.
3. That the proposed change of name is only a change in the name/identity of the existing school and shall not, by itself, result in any change in the ownership, management, sponsoring Society, location or legal status of the school.

4. That Great Ganges Education Society shall continue to be the Society responsible for running and managing the school after the proposed change of name.

5. That the proposed name "GGES International School" shall come into effect from 1st April 2027, subject to obtaining the requisite No Objection Certificate (NOC), permission and/or approval from the competent State Government/Education Authorities, Central Board of Secondary Education (CBSE), and any other authority, wherever applicable.

6. That the Society shall not represent or use the proposed changed name as an approved name before obtaining the requisite permissions/approvals, wherever such prior approval is required.

7. That the change of name shall not adversely affect the academic interests, rights or continuity of the existing students, parents, teaching/non-teaching staff or any other stakeholder of the school.

8. That all academic and administrative records of the existing students and employees shall be duly maintained and continued, and necessary changes in the school records shall be made in accordance with the directions/approval of the competent authorities.

9. That the Society undertakes to comply with all conditions, rules, regulations, directions and requirements prescribed by the competent Education Authority/State Government and CBSE in relation to the proposed change of name.

10. That all necessary amendments/changes in the school's records, signage, stationery, website, official correspondence and other documents shall be made only in accordance with the approval granted by the competent authorities and from the applicable effective date.

11. That there is no intention to misrepresent, conceal or alter the legal identity of the Society or the status of the school through the proposed change of name.

12. That the Society shall be responsible for complying with any additional requirement or condition that may be imposed by the competent authority while granting the NOC/approval for the proposed change of name.

13. That this affidavit is being executed for submission before the competent Education Authority/State Government/CBSE and/or any other concerned authority for obtaining the requisite NOC, permission and approval for change of the school's name from "Mount Litera Zee School, Unnao" to "GGES International School".
